Shaila has raised money for Syrian refugees, fundraised for marginalized Black youth, been one of the voices for women, and helped facilitate Muslim–Indigenous partnerships. She is author of the book “Maariyah’s Day”, about a girl’s experience being a Canadian Muslim. Shaila loves working with people of different cultures and religions and strives to build bridges. This has led her to pursue her masters in theology at U of T. Shaila is proud of her interfaith work (serving as CIC Co-Chair since 2022) and CBC Radio 1 freelancing stories about the multicultural tapestry in Canada.

Akaash Maharaj is Ambassador-at-Large for the Global Organization of Parliamentarians Against Corruption (GOPAC). He represents the international alliance of democratically-elected legislators in its work combatting corruption, strengthening good government, and upholding the rule of law. He also leads GOPAC's project on international prosecution of Crimes Against Humanity and its work on reconciliation in post-conflict states. The United Nations selected him to speak for the world's legislators in the General Assembly Chamber, on bringing kleptocrats to justice. Earlier in his life, he was an international athlete for Canada, and was a triple gold medallist at the International Championships of Equestrian Skill-at-Arms. He earned his Master of Arts from Oxford University, and was the first overseas student elected President of the student government in the history of the 900 year-old University. He completed further studies at the Sorbonne Université and the United Nations University.



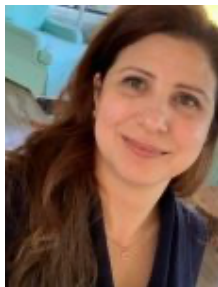
**Andrea Salguero**

Haseen is an executive member of the Muslim Association of Newfoundland and Labrador (MANAL), and currently serves as Treasurer. He served as VP from 1998 – 2000 and Interim President in 2000. Haseen represents MANAL on the interfaith in St. John's and NL Religious Social Action Coalition for poverty reduction. He delivers Friday sermon at the Mosque and is MANAL's Marriage Officer and Pastoral Care contact. He has helped establish the Newfoundland and Labrador Food Umbrella Inc. (NLFUI) and is on the Board of Directors. Haseen is a recipient of the Senate of Canada 150 Anniversary medal for his volunteer services to the Muslim Association of Newfoundland and Labrador.

May is an activist and community advocate dedicated to upholding the human rights of refugees, with extensive expertise in equality, racism and inclusion, immigration, and refugee laws, including sponsorship agreement holders. Her support for refugees extended to settlement, including housing, employment, healthcare, and education. From 2015 to 2022, she served as one of the inaugural members of the Victoria Counseling Centre for Immigrants and Refugees, fulfilling the roles of a medical interpreter and cultural educator. From 2022 to 2024, she represented the Muslim and Refugee communities on the Greater Victoria Police Advisory Diversity Committee. Since 2020, May has represented the Muslim faith at the Victoria Multifaith Society, and in 2024, she was elected as the society's chairperson. May continues to advocate for refugees, focusing on building bridges, fostering inclusion, and promoting human rights.
